Committee Reports

Treasurers Report: Keri Burress said she went to Hillsdale to pick up the check for the 2020 delinquent taxes and assessments. She has also been collecting property taxes and making bank deposits.

Clerks Report: Margy Burress said she had filed paper work for Covid Relief (ARP) Program. If approved the village should receive \$54000.00 paid in 2 installments. She is working on the audit for workers comp insurance and the Title VI Certificate for MDOT. For the village audit Brent Shea wants quite a few things added to each account which all reconciliations for last year has to be redone. Emil G. Gravelle III has purchased the property at 404 W. Center St. and submitted plans to build a house and wanted the villages approval. He also wanted permission to stay in a camper long enough to build the house. Shawn Barnhart made a motion to approve the plans for the house. Bill Hall supported and it carried by a voice vote. Bettie Salmon made a motion to allow the camper until Nov. 30, 2021 and if needed he can ask for an extension. Shawn Barnhart supported and it carried by a voice vote. Council Pay: Shawn Barnhart said he would like council members to donate their pay to a fund to be used for the park and anything else the village needs. Phyllis Worsley said we should be careful because if things aren't done right we could get in trouble with the IRS.

Public Comment: Brent Leininger said that the County Medical Care Facility was in need of employees and the county is working to find out what they need for brad band.

Shawn Barnhart made a motion to adjourn until Sept. 14, 2021. Bill Hall supported and it carried by a voice vote. Meeting adjourned at 8:20 p.m.
